




ARTICLE 3. TRUSTEES OR MEMBERS OF THE TRUST AND THEIR CATEGORIES:

All the authors of the Gurudeva Educational Trust, Kochi, all persons who contribute specified amounts in the manner provided hereunder in this deed to the Trust and nominees of all institutions and organisations which make such contribution and all persons co-opted as Trustees by the Board of Trustees as provided hereinafter in Clause (a) to (f) of Article 6 of the Trust Deed are trustees of Gurudeva Educational Trust, Kochi and their categories are as enumerated and specified in the above said article 6(a) to (f) of the Trust Deed.

ARTICLE 4. OBJECT.

a. The object of the Trust shall be the promotion of education among the public in general and the backward classes in particular and for that purpose to set up a public school and other allied institutions.

b. To establish and maintain institutions intended for the educational and cultural advancement of the public and their social welfare and physical well being.

c. This Trust will be a non-profit making one as envisaged in the provisions of the Income-tax Act, 1961.

To manage endowments and grant scholarships or other assistance to meritorious or deserving poor students to pursue their studies.




- e. To conduct coaching classes for those appearing for all India competitive examinations, such as I.A.S., I.P.S., I.F.S., etc.
- f. To conduct coaching classes for entrance examinations for Engineering, Medicine or other professional courses, State or Central, or for examinations for admission to the National Defence Academy.
- g. To conduct coaching classes for examination conducted by various Boards for recruitment to Banks, Railways, L.I.C. and other services.
- h. To conduct classes for students in fine arts, such as dance, music etc. (vocal and instrumental)
- i. To conduct classes for personality development, spoken English, Management studies, Journalism etc.
- j. To conduct classes for Sanskrit, Hindi, Arabic, Vedanta, Yoga and other spiritual pursuits.
- k. To organise conducted tours with educative value to place of national importance.
- l. To adopt or take over any other trust or any society registered under the Societies Registration Act or under Similar statutes with objects similar to that to this Trust.

- n. To accept donations, grants, presents and other offering from individuals, institutions and Governments, and to deal with the same for the purpose of the Trust.

- o. To purchase and maintain vehicles necessary for carrying out the objects of the trust.
- p. To engage in any other activity which will be conducive to the object of the trust.

ARTICLE 5. BOARD OF TRUSTEES:

The overall administration, management and control of the affairs of the Trust and its properties shall vest in a Board of Trustees.

ARTICLE 6. CONSTITUTION OF THE BOARD OF TRUSTEES:






There shall be the following categories of Trustees and the Board of Trustees shall be constituted from such categories of Trustees in the manner provided hereunder:

a. TRUSTEES BY AUTHORS:

The five authors of the trust above named who are eligible to be hereditary trustees on contributing further sum required as provided in Clause (b) of Article 6 of the Trust Deed.

b. HEREDITARY TRUSTEES

All authors of the trust satisfying the conditions laid down in Clause (a) above and every individual who donates a sum not less than Rs. 25,000/- (Rupees Twentyfive thousand only) to the Trust shall be hereditary Trustees and each of such hereditary trustees shall also be in the Board of Trustees. In the event of death of any hereditary trustee or in the event of his vacating the place in the Trust on any other reason, unless a nominee to succeed him is duly registered in the office of the Trust by the hereditary trustee by filing an application attested by two witnesses one of whom a member of the Executive Committee of the Trust; his eldest legal heir shall be entitled to fill up his vacancy in the Trust, subject to article 6 Clause (h) below.

c. LIFE TRUSTEES - GROUP -A

Every individual who contributes not less than Rs. 5000/- (Rupees Five thousand only) to the Trust shall be life trustees Group-A and such trustees shall be represented in the Board of Trustees by one such trustee for every ten such trustees subject to the condition that such representation of the life trustees-group-A shall not exceed 10% of the hereditary trustees in the Board of Trustees.

d. LIFE TRUSTEES - GROUP -B

Every individual who contributes not less than Rs. 1,000/- (Rupees One thousand) to the Trust shall be life trustees Group-B and such trustees shall be represented in the Board of Trustees by, one such trustee for every 50 of such trustees subject to the condition that such representation of the life Trustees Group-B shall not exceed more than 5% of the hereditary trustees in the Board of Trustees.

e. NOMINATED/INSTITUTIONAL TRUSTEES

One representative of every institution or organisation having identical views of the trust that donate to the trust a sum not less than Rs. 25,000/- (Rupees Twentyfive thousand only) nominated by such organisation or institution who shall be a nominated trustee or institutional trustee for such period as is determined by such bodies and duly intimated to the Trust and each of such nominated trustees will be represented in the Board of Trustees.

Any distinguished person or persons of pre-eminent repute and outstanding career chosen by the Board of Trustees as honorary trustees for a period of three years and o-opted to the Board of Trustees and such honorary trustees on the Board of Trustees shall not be more than two at a time as provided in Article 7 (d).

g. The tenure of office of the Board of Trustees shall be three years, Provided such Board of Trustees will continue in office till a duly elected Board assumes charge.

h. No persons shall be eligible to hold office of the Trustee, who is a minor, insolvent, a person of unsound mind, a paid servant under the Trust or any of the institutions under the Trust, a person convicted for a criminal offence involving moral turpitude, or any person against whom disciplinary action is taken and punishment inflicted for serious allegation of corruption or misbehaviour in any other trust or society.

i. Notwithstanding the tenure of office of nominated or institutional trustees as above fixed, they shall continue in office until their successors assume office unless objected to by the institution or organisation nominating them.

j. Vacancies of Life Trustees in Group-A and Group-B in the Board of Trustees, arising from death, resignation or other causes may be filled by the Board by inducting their successors or nominees elected by such life trustees group A or B as the case may be, who are no disqualified as per Clause (h) of Article 6 above; such trustees shall hold office only for the unexpired period of the Board's tenure.

k. Not withstanding anything contained elsewhere in this deed, the first Board of Trustees shall be constituted by the five authors of the Trust above named. They shall elect from

of the Trust along with the President, Secretary and a Treasurer. The authors of the Trust along with the President, Secretary and Treasurer shall for the time being constitute the first Executive Committee. They will hold the office until a regular election among the Board of Trustees is conducted.

- l) The election of the regular President, Office bearers, the members of Board of Trustees and Executive Committee shall be conducted as soon as the required quorum of the Board of Trustees is reached.
- m) The Board of Trustees shall meet atleast once in every three months and the annual meeting of the Board of Trustee be held within four months of the closing of the financial year to evaluate the working of the Trust and the Institutions under the trust and to consider and pass the audited accounts and report. The quorum for a meeting of the Board shall be 25% of the total number of members of the Board of Trustees or 20 members present whichever is less.
- n) Annual general body of the Trust will meet once in an year within 4 months of the closing of the financial year. The secretary will apprise the meeting the overall working and financial affairs of the Trust for the previous year.
- o) To elect the specified categories of trustees to the Board of Trustees a General Body meeting of the members of the Trust will be held once in every three years, atleast two weeks prior to the date fixed for the last annual general meeting of the Board of Trustees during its each tenure. The representatives of such categories like life Trustees Group-A and Life Trustees Group-B shall be elected from each of such groups by

The Board of Trustees shall have the following powers:






- a) To manage, administer and control the Trust fund and properties and institutions belonging to the Trust or under its management.
- b) To take on lease, purchase or otherwise acquire and to sell and otherwise dispose of any property, movable or immovable for the purpose of the trust or the constituent institutions belonging to or under the management of the Trust.


Provided that no immovable property of the Trust shall be pledged, sold or otherwise disposed of without the authority of the Board of Trustees obtained by a resolution passed by two-third majority of the members of the Board present and voting in the meeting specially called for the purpose.

- c) To take on rent, purchase or construct buildings for the purpose of the Trust or the institutions belonging to the Trust.

- d) To choose not more than two eminent persons as honorary trustees and to co-opt them as members of the Board of Trustees for a period of three years but such honorary trustees in the Trust or in the Board of Trustees shall not be more than two at any time.

To frame rules and regulations that are not repugnant to the provisions of this deed necessary for the proper and efficient administration of the Trust and the Institutions under the Trust.

- f) To borrow such amounts from individuals or from institutions on the security of the land, buildings and other assets of the Trust, or otherwise, for any of the objects of the Trust, Subject to the proviso to Clause (b) above.
- g) To appoint on such terms and conditions as the Board prescribes from time to time, officers, technical and professional hands etc. as they deem necessary and expedient for the purpose of maintaining the institutions under the trust and to take appropriate disciplinary actions including termination of service.
- h) To appoint auditor or auditors to audit the accounts of the Trust and of the institutions under the trust and to fix his or their remuneration.
- i) To admit as members of the Trust in the respective Categories, those who contribute the specified amount under Clause (b), (c), (d) and (e) of Article 6 above.

ARTICLE 8. CONSTITUTION AND POWERS OF EXECUTIVE COMMITTEE

a) The Board of Trustees shall constitute from among them an executive committee consisting of not less than seven and not more than nine persons for a term of three years to carry on the functions stated hereinafter. A Committee whose period expires is entitled to continue in office till a duly constituted successor committee assumes charge. The Executive Committee shall have a President, Vice President, Secretary Joint Secretary and Treasurer and not less than 2 and not more than 4 committee members. The President, Secretary and Treasurer of the Board of Trustees shall be the Ex-Officio President, Secretary and Treasurer of the Executive Committee. The Vice President, Joint Secretary and the required members of the committee shall be elected from the Board of Trustees.

THE EXECUTIVE COMMITTEE SHALL HAVE POWER:-

- b) To fill up the vacancies in the Executive Committee, arising from death, resignation or other causes, but such action of the Executive Committee shall be got ratified by the Board of Trustees in their immediate next meeting.
- c) To appoint such employees and staff as may be necessary to carry on the day to day work and affairs of the Trust and to fix their salary and emoluments and service condition subject to the service condition as per Clause (g) of Article 7.
- d) To take disciplinary action against the employees or members of the staff including the power to suspend, remove or dismiss them from service.
- e) To open and operate in the name of the Trust or in the names of the institutions there under, account or accounts with such bank or banks as they consider proper and to pay or cause to pay to the credit of any such account any money forming part of the Trust Fund or to place such money on deposit with any bank. Subject to the provisions of the Income-tax Act, 1961. (Regulating investments by Charitable Bodies).
- f) To manage, administer and control the trust properties and the institutions under its management subject to the overall control of the Board of Trustees.
- g) In the event of the President, Vice-President, Secretary, Joint Secretary or the Treasurer ceasing to function on account of death, resignation, retirement or other causes, the Executive Committee may elect one from among them to act in such vacancy until the Board of Trustees elects a new incumbent.
- h) The quorum for the meeting of the Executive Committee shall be five.

1) Notwithstanding anything contained elsewhere in this deed, until the first executive committee comes into existence in accordance with the provisions of this article, the functions of the committee may be carried on by the Authors of Trust as referred to article 6(k).

ARTICLE 9. POWERS AND DUTIES OF THE PRESIDENT, VICE PRESIDENT, SECRETARY, JOINT SECRETARY AND TREASURER.

- a) The President, if present, shall preside over the meetings of the Executive Committee. In the absence of the President, The Vice President shall exercise and discharge the powers and duties of the President.
- b) The Bank accounts of the Trust and all the institutions under the Trust shall be opened in the joint names of the President, Secretary and Treasurer and the same shall be operated jointly by any two of them.
- c) The Secretary, subject to the control and supervision of the Executive Committee, may exercise and perform such powers and duties as the Executive Committee may from time to time determine and in general carry on the Executive functions of the Trust under the Deed of Trust.
- d) The Secretary shall be the Manager of the Educational Institutions under the Trust until otherwise decided by the Executive Committee and shall exercise such powers in this regard in accordance with the laws in force and that are conferred upon him by the Board of Trustees.
- e) The Secretary shall convene the meetings of the Trust, the Board of Trustees and of the Executive Committee in consultation with President. It shall be the duty of the Secretary to make available the income and expenditure settlement and a proforma

f) The Secretary shall place before the Annual General meeting of the Board of Trustees to be held within four months of the close of each account year the audited Income and expenditure statement and Balance sheet of the previous year with a report on the working of the Trust and of the institutions under the Trust and a budget estimate for the succeeding year.

g) The Secretary and in his absence the joint Secretary shall represent the Trust or Board of Trustees in all legal proceedings.

h) All documents to be executed or taken by the Trust shall be executed or taken in the joint names of the President and the Secretary.

i) The joint Secretary shall assist the Secretary generally and perform such functions and exercise such powers as are delegated to him by the Executive Committee and shall in the absence of the Secretary by death, resignation or other cause, perform all the duties and functions of the Secretary till a new Secretary is elected and assumed charges.

j) The Treasurer shall be responsible for maintaining proper accounts of the Trust Fund, properties institutions under the Trust and of all the transactions of the Trust, which shall be audited every year. The account year of the trust shall close on the financial year from 1st April to 31st March every year.
